Approval of Minutes: The Minutes for April 27, 2023, were ratified as revised and approved by the BOD and have been posted to Club at Cobble Creek website.

#### **Old Business**

- Revision to Easement Agreement / Community Improvement Fund Committee Report –
  There have been two meetings with the surrounding Cobble Creek developers. Requiring
  mandatory Club membership for new home builds is currently not a proposition. The
  focus is on the easement agreement between the communities.
- RV Lot Agreement Montrose Land Partners, LLC purchased Cobble Creek South which includes the current RV Storage Lot on 6450 Road. The BOD was able to negotiate an agreement with Montrose Land Partners to keep the lot as a Club amenity until December 31, 2024. This agreement has the potential of being extended beyond such date based on Developer needs.

An email will be sent to all existing Club member RV Lot Lessee's to review new contract. Once the lot is reorganized with current lessees, the lot will be open to Club member on a waiting list.

All RV's or equipment stored in the lot by non-Club members or members who do not wish to renew their contract will need to vacate by July 7 unless other arrangements are approved and made through <a href="mailto:RVManager@cobblecreek.com">RVManager@cobblecreek.com</a>.

• 2024 BOD Election – The process will begin in November 2023 to invite candidates to submit their resumes for a January election. There will be two BOD seats available for a two-year term.

• Bridge Repair at Cobble Creek Community Entrance – This will be a 50/50 cost share between the Club and the Cobble Creek HOA. Bids are being sought, however no pricing has been obtained as of date.

## **New Business**

- General Manager Search Process Eric Wolf to lead search committee effort.
- BOD Roles and Structure in Absents of General Manger CC BOD discussed and assigned the following BOD to Champion Club business operations.

• Policy for Returning Club Membership – It was discussed to allow former members to be reinstated with no additional initiation fee. The process will require to sign a new membership agreement and pay monthly dues. An announcement will be posted via email to the membership.

There being no further business, a motion to conclude the General Session and move to the Executive Session of the Board was duly made. It was seconded, and unanimously carried. The General Session was adjourned at 6:30 PM and the BOD proceeded into Executive Session.
